A meeting of the faculty of the INSTITUTE FOR INTERNATIONAL MEDICINE, was held on the 29th day of December 2022 via Zoom.

Nicholas Comninellis acted as leader of the meeting. The following persons were also present: Fred Loper, Lori Myrick, Scott Armistead, Joe LeMaster, John Gibson, and Micah Flint.

The meeting began with each faculty describing their personal history, service experience, and roles at INMED. For some faculty, this was their first interaction with one another.

Nicholas Comninellis providing an update on the status of accreditation with the the New England Commission for Higher Education (NECHE) and the Missouri Department of Education. Both are steadily progressing, with NECHE Candidacy status anticipated within about a year and Missouri certification within the coming weeks.

Nicholas Comninellis described his vision for the INMED faculty, emphasizing INMED distinctives: Christ-centered leadership and excellent humanitarian care. He further stressed that the faculty are the primary voices of these distinctives. In the slight, he quoted from John 13:34-35 "A new command I give you: Love one another. As I have loved you, so you must love one another. By this everyone will know that you are my disciples, if you love one another." This was followed by a lively discussion among the faculty surrounding the importance of role, modeling and caring interaction with INMED learners. Micah Flint concluded the meeting saying in essence, *We fully expect that 100 years from now INMED faculty well continue to express these distinctives*.

There being no further business, the meeting was adjourned.

Faculty by Category

- Full-time faculty means personnel who teach three course offerings or more per academic year. They are responsible for teaching, advising, attending faculty meetings, participating in the Faculty Council, and curriculum design.
- Part-time faculty means personnel who teach two course offerings or fewer per academic year. They are responsible for teaching, advising, attending faculty meetings, participating in the Faculty Council, and curriculum design.
- Adjunct faculty means personnel who may teach a course or participate in other advisory activities. They may attend faculty meetings at the discretion of the President.
- Visiting faculty means personnel who only teach a Professional Qualification Course. They do not attend faculty meetings.

Faculty by Rank*

- Professor means personnel who: hold 2 or more advanced degrees, have published 3 or more peer-reviewed publications, have 5 or more years relevant teaching experience, and who serve as a full-time or part-time faculty member
- Associate means personnel who: hold a minimum of 1 advanced degree, have published 2 (or fewer) peer-reviewed publications have less than 5 years relevant teaching experience, and who serve as a full-time or part-time faculty member
- Assistant means personnel who: hold a minimum of 1 advanced degree, have published 2 (or fewer) peer-reviewed publications have less than 5 years relevant teaching experience, and who may co-teach a course or participates in other advisory activities.
- Instructor means personnel who: only teach a Professional Qualification Course, and does not participate in faculty meetings.

*Significant consideration is given for professional experience that relates to INMED's mission. Additional consideration is given to relevant training and credentials appropriate to the course(s) being taught.

They are responsible for teaching, advising, attending faculty meetings, participating in the Faculty Council, and curriculum design.
- Instructors are personnel who are qualified in their area of expertise; they do not attend faculty meetings.

INMED Faculty Council Bylaws

Faculty Bylaws, INMED, draft 7/28/2023

ARTICLE I. Membership

The Institute for International Medicine (INMED) Faculty Council consists of all members of the Academic Faculty with the rank of Professor and Associate Professor at INMED; all such faculty members have the right to vote in INMED faculty meetings.

ARTICLE II. Duties of the Faculty

INMED Faculty are responsible for teaching and service, and for upholding the standards of INMED and the principle of academic freedom. To these ends, INMED's Faculty:

a. Review and, as warranted, approve all new academic programs, and significant changes to existing programs. The introduction of, and significant changes to, all degree requirements, curricula, and courses, are subject to the approval of the Faculty; the Faculty also offer advice as needed about academic programs.

b. Review any proposal to eliminate or curtail programs.

c. Participate in discussions concerning the academic organization of INMED.

d. Elect the Dean of the Faculty by vote, who shall serve 3-year terms subject with the possibility of reappointment.

e. Approve by vote all new faculty, and the promotion of existing faculty through peer review.

f. Represent INMED to the general public.

ARTICLE III. Faculty Meetings

Section 1:

During the academic year, meetings of the Faculty will be called no less than three times per year, and led by the Dean of Faculty, or the Dean's designee. Notice of the meeting and its agenda, and the minutes of any previous meeting, shall be circulated seven days in advance.

Section 2:

The agenda of a meeting of the Faculty shall be prepared by the Dean of Faculty. It shall be the responsibility of the Dean of Faculty or the Dean's representative to ensure that all faculty members of the Institute have sufficient means and opportunity to contribute to meeting agendas as warranted. Agendas will reserve time for matters from the floor.

Section 3:

The Dean of Faculty or his/her representative shall preside over meetings of the Faculty.

Section 4:

Means of remote attendance shall be provided. Faculty members attending in person or remotely shall be deemed present. If a quorum consisting of a majority of Faculty members are present and vote at the meeting, motions may be adopted at the meeting by immediate vote; adoption is by a majority of votes cast.

Section 5:

If a quorum is not obtained, but at least 25 percent of Faculty members are present, motions may be made and seconded at the meeting, and those motions securing a majority of votes cast at the meeting are then referred to the entire voting Faculty for electronic vote over a voting period of at least 24 hours. In this case, if (a) a majority of Faculty members cast a vote (signifying the equivalent of a quorum), and (b) the motion secures a majority of votes cast, the motion has passed.

Section 6:

Minutes of every faculty meeting shall be taken by a scribe designated by the Dean of

Faculty and archived. Minutes are subject to approval by vote of the Faculty at the next Faculty meeting.

ARTICLE IV. Amendments

Amendments to the Bylaws may be made at any regular or special meetings of the Faculty, provided due notice of the proposed change has been distributed to the members of the Faculty at least seven days in advance of the meeting at which the amendment will be considered. Amendments are proposed as motions and are adopted by majority vote as provided in Article *III*.

INMED Faculty Council Bylaws

Faculty Bylaws, INMED, draft 7/28/2023

ARTICLE I. Membership

The Institute for International Medicine (INMED) Faculty Council consists of all members of the Academic Faculty with the rank of Professor and Associate Professor at INMED; all such faculty members have the right to vote in INMED faculty meetings.

ARTICLE II. Duties of the Faculty

INMED Faculty are responsible for teaching and service, and for upholding the standards of INMED and the principle of academic freedom. To these ends, INMED's Faculty:

a. Review and, as warranted, approve all new academic programs, and significant changes to existing programs. The introduction of, and significant changes to, all degree requirements, curricula, and courses, are subject to the approval of the Faculty; the Faculty also offer advice as needed about academic programs.

b. Review any proposal to eliminate or curtail programs.

c. Participate in discussions concerning the academic organization of INMED.

d. Elect the Dean of the Faculty by vote, who shall serve 3-year terms subject with the possibility of reappointment.

e. Approve by vote all new faculty, and the promotion of existing faculty through peer review.

f. Represent INMED to the general public.

ARTICLE III. Faculty Meetings

Section 1:

During the academic year, meetings of the Faculty will be called no less than three times per year, and led by the Dean of Faculty, or the Dean's designee. Notice of the meeting and its agenda, and the minutes of any previous meeting, shall be circulated seven days in advance.

Section 2:

The agenda of a meeting of the Faculty shall be prepared by the Dean of Faculty. It shall be the responsibility of the Dean of Faculty or the Dean's representative to ensure that all faculty members of the Institute have sufficient means and opportunity to contribute to meeting agendas as warranted. Agendas will reserve time for matters from the floor.

Section 3:

The Dean of Faculty or his/her representative shall preside over meetings of the Faculty.

Section 4:

Means of remote attendance shall be provided. Faculty members attending in person or remotely shall be deemed present. If a quorum consisting of a majority of Faculty members are present and vote at the meeting, motions may be adopted at the meeting by immediate vote; adoption is by a majority of votes cast.

Section 5:

If a quorum is not obtained, but at least 25 percent of Faculty members are present, motions may be made and seconded at the meeting, and those motions securing a majority of votes cast at the meeting are then referred to the entire voting Faculty for electronic vote over a voting period of at least 24 hours. In this case, if (a) a majority of Faculty members cast a vote (signifying the equivalent of a quorum), and (b) the motion secures a majority of votes cast, the motion has passed.

Section 6:

Minutes of every faculty meeting shall be taken by a scribe designated by the Dean of

Faculty and archived. Minutes are subject to approval by vote of the Faculty at the next Faculty meeting.

ARTICLE IV. Amendments

Amendments to the Bylaws may be made at any regular or special meetings of the Faculty, provided due notice of the proposed change has been distributed to the members of the Faculty at least seven days in advance of the meeting at which the amendment will be considered. Amendments are proposed as motions and are adopted by majority vote as provided in Article *III*.
